RURAL MUNICIPALTY of ABERDEEN No. 373 BYLAW NO. 2021-05

A bylaw to amend Bylaw No. 2007-04, the Official Community Plan (formerly known as the Basic Planning Statement) of the Rural Municipality of Aberdeen No. 373.

The Council of the Rural Municipality of Aberdeen No. 373, in the Province of Saskatchewan enacts to amend Bylaw No. 2007-04 as follows:

- 1. Section 5 RESIDENTIAL LAND USE AND DEVELOPMENT 5.3 POLICIES IMPLEMENTATION (8)(a) Single Parcel Country Residential Policy Locational Policies is amended by deleting subsection (i) and replacing it with the following new subsection:
- "(i) To retain the agricultural character of the Municipality, a maximum of three separate subdivided single-parcel country residential sites per quarter section plus remainder will be allowed at the discretion of Council. In order to minimize conflict between single-parcel country residential subdivisions and other development, subdivision and subsequent development will be allowed, subject to the following separation policies:
 - minimum 400 metres from a wildlife management area or bird sanctuary.
 - minimum 2 kilometres from the corporate limits of an urban municipality, or the edge of designated country residential district when it is demonstrated that a conflict will result with the future long-term development of such area.
 - minimum 1.6 kilometres from an area that may be used for industrial purposes or large scale agricultural related commercial uses;.
 - minimum 200 metres from an existing or proposed gravel pit operation."

2. This bylaw shall become effective on the date of approval of the M	inister of Government Relations.
