Permit Fees**

HAMOLINE: BE IT RESOLVED that the Council of the Rural Municipality of Aberdeen No. 373 adopt the order issued under the Authority of Section 36.1 of the Ministry of Highways and Transportation Act, 1997 to issue a permit under section 36 of the said Act with respect to an overweight vehicle, the fee charged for the permit shall not exceed a maximum of:

1. \$ 50.00 per single trip with the exception of a road subject to a spring road restriction order;
2. \$ 100.00 per single trip on a road subject to a spring road restriction order; and
3. \$ 300.00 for a permit allowing more than one trip in a twelve-month period commencing on the date the permit is issued.


BE IT FURTHER RESOLVED that the council of the Rural Municipality of Aberdeen No. 373 shall charge the maximum fee as indicated for resolution.
