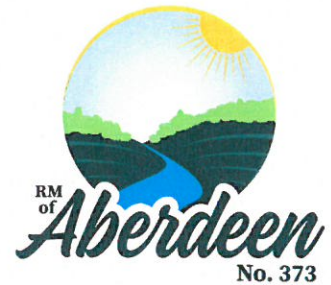

Kevin Friske made a representation to Council in favour of the proposed subdivision.


