#### Next Council Meeting: January 9th, 2025

Council Meetings are held on the second Thursday of every month and begin at 8:00am, unless changed by Council. Any delegations wishing to address Council will be required to contact the office at least one week prior to the meeting.

January 1st - July 31st: 6% | August 1st - August 31st: 4% | September 1st - September 30th: 2% | October 1st - December 31st: 0% Please visit our website for more information on taxes, including payment options.

December 31<sup>st</sup>, 2024 was the last day to pay 2024 Taxes. Penalties at a rate of 1% per month began accumulating on unpaid balances effective January 1<sup>st</sup>, 2025.

## 2025 Tax Pre-payments:

While 2025 Taxes will not be levied until mid-June, the 6% discount on the Municipal (MUN) portion of taxes came into effect January 1<sup>st</sup>, 2025.

If you have paid off your 2024 Taxes in full and wish to begin making pre-payments towards your 2025 Taxes, these payments are eligible for the 6% MUN discount.

## **Policy Post:**

The RM of Aberdeen has an Extreme Weather Policy in place.

We recognize the hazards extreme weather pose to Municipal employees and equipment. The purpose of this policy is to establish measures to ensure the protection of the Municipal employees and equipment and reduce the risk of worker injury/damage to equipment from the hazards of working in extreme cold conditions.

During the winter months, Municipal equipment shall not be operated at temperatures in which the daytime high is less than -30°C or when the wind chill factor is in excess of -35°C. This will be at the Foreman's discretion and/or Council's discretion.

The following exceptions will be permitted:

In cases of emergency when determined by the Foreman or Council

Kevin Kirk was reappointed as the Deputy Reeve for the remainder of 2024 and for 2025.

The next election is for Councillors of Divisions 2, 4, and 6 will be held in November of 2026.

### **School Tax Declaration:**

The RM Office will be closed at 3:00pm on Tuesday, December 31st, 2024 and all-day Wednesday, January 1st, 2025

If, for the 2025 Tax Notices:

- 1. You are an undeclared property owner who wishes to declare Separate School support;
- 2. You are a previously declared Separate School supporter who wishes to declare Public School support;
- 3. You are a previously declared Public School supporter who wishes to declare Separate School support, or;
- 4. A property is sold under a bona fide Agreement for Sale.

Please fill out the School Tax Declaration Form and submit to the RM Office by February 28th, 2025. Taxes are automatically paid to the Public School, unless changed through submission of the aforementioned form.

### **COUNCIL'S CORNER**

Town Council meetings are open to the public.

Council meetings are held at the TOWN OF ABERDEEN Office Chambers, 401C Main Street, at 7:00 pm every 3<sup>rd</sup> Tuesday of the Month.

Our next council meeting is scheduled for Tuesday, January 21st, 2025.

Any Delegations wishing to address Council are required to complete a Delegations Policy form and have it submitted to the Town Office no later than the Thursday prior to Council meeting date. You may obtain these from the Town Office. These forms are also available on our website www.aberdeen.ca

### **2025 Business Licenses**

According to Bylaw 12/14 the Business License Bylaw, all Home Based, Store Front and Contractor Business Licenses for 2025 are due December 31, 2024, and are valid until December 31, 2025.

License fees:

Home Based Business \$25 annually Store Front Business \$75 annually Contractor \$100 annually

General Contractor \$300 (covers the trades, as part of the building permit)

The offence for conducting business without a Business License is \$200. Bylaw Enforcement will be issuing fines for non-compliance.

### It's never too early for a SNOW REMOVAL PLAN

Snow removal will be done on roadways from Monday through Friday, and weekends by necessity only. Sand/gravel will be spread on streets and corners where icy, and as needed to help diminish potential risks to our residents and vehicular traffic.

**Priority 1:** School Route – Central Avenue, Main Street, Second

Avenue and Thompson Street

**Priority 2:** Emergency Services – Industrial Drive, Fifth Avenue

South

**Priority 3:** Residential Streets, Main Street Sidewalk

**Priority 4:** Alleys where required.

#### **RESIDENT RESPONSIBILITIES:**

Residents may help by clearing the front of their property where sidewalks exist. Bylaw 03/13 prohibits residents from placing any snow, ice, dirt or other obstruction, swept or cleaned from private property onto any street, sidewalk, lane, ditch, drain or sewer.

The Town Office receives calls from residents regarding the snow removal equipment depositing snow at the end of driveways. Unfortunately, this is a reality of snow plowing, and it cannot always be avoided. If you have a neighbor who is unable to remove their snow from in front of their driveway please assist them, as we often do not have the resources to go back and clear driveway approaches. We ask kindly for your cooperation and understanding as our staff continue to keep our streets cleared and safe during the winter months.

#### **Sign Corridor**

#### 2025 Sign Corridor

The annual fee of \$200.00 plus GST will be billed to each sign owner to cover the cost of yearly land maintenance and must be paid by January 31 of each year. This fee has been set by council and may be scheduled to increase periodically as determined by council.

When a sign is in need of repair or replacement, the Town will send a letter to you/your business. If there has been no action to remedy the sign within two weeks of the date of the letter, the Town crew will be instructed to remove the sign from the corridor and this space in the corridor will become available to another business.


c) Signs will not be insured under Town of Aberdeen, if damages occur the sign owner is responsible to cover the costs of any repairs or replacement.

## Penalties for 2024 Tax arrears will be as follows:

August 1 (compounded monthly) 1%
September 1 1%
October 1 1%
November 1 1%
December 1 1%
On January 1, 2025 a 12% penalty will be applied to 2024 arrears

Taxes are imposed the first day of January in each year and are due July 31.

Please remember there is NO discount for the School Portion of Taxes

Tax <u>Estimate</u> Notices for 2025 taxes will be sent in January 2025. 2025 Tax Notices will be sent mid May/ beginning of June, once the School Division levies have been established and the Municipal Mill Rate has been set.


