## Class 2 & 3 Supplemental Information Required for C1, CR1, CRMU, CR2, CR2A, CR3

- □ Application for C1 or CR Subdivision
- Drainage and grading plans to accommodate surface water from a 1:500 year flood event.
- □ Phase 1 Environmental and, if warranted, a Phase II environmental assessment for any site with potential soil contamination.
- □ Site Grading Plan for the subdivision area.
- □ Traffic Impact Assessment
- □ Heritage Site Review

Please note that a proposed subdivision will require the execution of a servicing agreement with the RM. Fees associated with the administration, legal services and engineering as contained within the agreement will be the responsibility of the applicant.
